Telford Lake Natural Area

- Administration is tasked with looking into potential opportunities further and reporting back before budget in June with estimated costs and feasibility.
- Edmonton Area Land Trust process with MDP negotiations:
- Administration reviews feasibility of the various options presented.

- Administration presents options to Council with associated budget askes.
 - Council grants Administration approval to proceed (hopefully).
 - Administration conducts internal research where possible and posts RFP's/RFQ's to secure consultant support where needed.
 - Consultants design and execute studies, evaluations, and assessments.
 - Together Administration and LEAB review the findings.
 - These results can then be used to inform next steps which could include: drafting an MDP amendment that speaks to the value of Telford Lake and/or provides new development guidelines, asking the City to buy back land around the lake to expand setbacks, asking the City to re-zone the land around the lake to increase Environmental Reserve and the associated mechanisms of protection that come with it, or entering into discussions and negotiations with private landowners around conservation easements and land donation options.
