Background

1. <u>Speeding Concerns in Edgewater Circle (Edgewater Circle & Sheppard Blvd) (Shawn Olson)</u>

Resident expressed concern with regard to speeding while entering Edgewater Circle. They are requesting a reduction in speed to 30 kms/h and a sign be posted. As you enter Edgewater Circle, there is a very tall fence that makes it very dangerous to see any pedestrians crossing the street. She has seen small children almost hit several times.

<u>September 19, 2024 Meeting:</u> TAC reviewed the area of concern and will install a speed awareness sign to capture the data and bring back to next meeting.

<u>November 14, 2024 Meeting:</u> TAC reviewed the speed awareness data. The data showed the average speed is 25 km/h with an 85 percentile of 30 km/h. This is below a threshold where it would merit engineering control.

Decision

TAC Recommends to Council that no further action be taken.

Background

2. Traffic Signal Concern West Haven Dr & Black Gold Dr (Shawn Olson)

Resident has expressed concern for more attention to be drawn to intersection at West Haven Dr and Black Gold Dr as the sunlight/trees are an added factor to already distracted drivers when driving west on Black Gold Dr. Resident suggested rumble strips as possible solution.

<u>September 19, 2024 Meeting:</u> TAC reviewed the area of concern and concluded that a 4 way stop would impede traffic flow, especially during school drop off and pick up times. Enforcement services to monitor the area for distracted drivers. Install speed awareness sign to capture west bound traffic and bring data back to the next meeting.

November 14, 2024 Meeting: TAC reviewed the speed awareness data from the west bound sign on Black Gold Dr. The average speed is 46km/h with an 85 percentile of 51 km/h and a high of 110km/h. TAC will change the speed awareness sign from covert to flashing and continue to gather further data over the next six months. Data to be brought back to a future meeting to discuss results and possible solutions at that time.

Decision

TAC Recommends to Council that the speed awareness sign be changed from covert to flashing and continue to gather further data over the next six months and then discuss results and solutions at a future meeting.

Background

3. <u>Traffic Signal Concern at Ohpaho Secondary School & 69 St (Kyle Van Steenoven)</u>

The Principal of Ohpaho Secondary School is requesting the stop sign at the South entrance to the school parking lot be changed to a yield sign to improve traffic flow out of the student parking lot as this is the entry/exit for all the student parking and with students trying to obey the stop sign, traffic gets backed up and it takes a considerable amount of time to get students out at the end of the day.

<u>September 19, 2024 Meeting:</u> TAC reviewed the area of concern and will wait to see if the continuation of 69 St South to connect with Black Gold Dr is approved in the budget discussions in October. If the road extension is approved in the budget, the sign will remain a stop sign as the through road will follow imminently and its poor practice to change road signs frequently. If the intention is not to connect the road in the short term, the sign will be changed to a yield sign until the road is extended in the future.

<u>November 14, 2024 Meeting:</u> TAC noted that the budget discussion regarding the continuation of 69 St south resulted in an unknown timeline for its completion. Therefore, TAC will allow the school to replace the stop sign with a yield sign.

Decision

TAC Recommends to Council that the stop sign on 69 St S at the south entrance of the Ohpaho parking lot be changed to a yield sign.

Background

4. Speeding Concern Along Blackstone Blvd (Shawn Olson)

Resident is concerned about speeding along Blackstone Blvd. Signage for speed limits and flashing speed limit signs are only up in one direction going into the suburb. There are no signs when people are driving west. No signs are up by the children's playground. The building site is a frenzy of hundreds of workers and trucks in and out daily and passing the children's park at double or more the speed limit. Resident has almost been struck herself. Can we please get this addressed before a life is lost? Kids are kids running across the road into the park sometimes without pressing the pedestrian crossing button. Doing 20 may be a broken bone if a kid is struck, but 80 is a death sentence.

Please let's be proactive, this is getting out of hand with the builders.

<u>September 19, 2024 Meeting:</u> TAC reviewed the speed awareness data and the average speed is 34 km/h with an 85th percentile of 40 km/h. The speed awareness sign will be installed on the opposite side of the road to record data and be brought back to next TAC meeting.

<u>November 14, 2024 Meeting</u>: TAC reviewed the speed awareness data for westbound traffic and the average speed is 36km/h with an 85th percentile of 44km/h and a maximum speed of 85km/h. This is below a threshold where it would merit engineering control. However, the project manager for this area will contact the developer to remind construction companies to obey traffic laws.

Decision

TAC Recommends to Council no further action be taken.

Background

5. Request for Increased Security as Street Lights are Inoperable due to Construction on 57 Ave (Shawn Olson)

Due to construction, the streetlights along 57 Ave are inoperable until the road work is complete. Resident has complained about dark streets leading to increased break and enters to properties in Willow Park. TAC to review if the traffic conditions have led to increased security issues to see if increased patrols or other accommodations are warranted.

<u>September 19, 2024 Meeting:</u> TAC reviewed the area of concern and confirmed the area is dark. However, the alternative is to run a diesel generator which would disturb the neighboring residents. TAC has requested the RCMP to investigate reports of break and enters in the area to validate the safety concern.

<u>November 14, 2024 Meeting:</u> TAC noted that the City installed temporary lights using a generator to provide a safe environment for Halloween trick or treaters. No incident reports of concern were brought forth by RCMP. Fortis to have lights in working condition by November 15, 2024.

Decision

TAC Recommends to Council that no further action be taken.

NEW BUSINESS ITEMS

Background

6. Traffic Signal Concern 47 St and 49 Ave (Shawn Olson)

Resident is requesting clarification for traffic signals for this intersection. This intersection is very confusing. Heading south bound on 47 St, drivers come to a yield at 49 Ave. There is also a yield sign on 49 Ave as drivers approach 47 St heading east. So who yields to who? Does the driver who gets there first have the right of way? Or if you are heading south on 47 St and come to the yield sign, are you supposed to yield to left turning traffic. Yielding to left turning traffic when I am going straight through is a new one for me.

<u>November 14, 2024 Meeting:</u> TAC reviewed the intersection and concluded the two existing yield signs should be replaced with stop signs and a third stop sign be installed to facilitate a 3-Way stop.

Decision

TAC Recommends to Council that the existing yield signs be replaced with stop signs and a third stop sign installed to facilitate a 3-Way stop.

Action

Public Services to replace existing yield signs with stop signs and install a third stop sign along with "3-Way" signs mounted under each main sign

7. Request for Crosswalk Flashers Across Blackstone Blvd Where it Intersects with Berg PI & Boulder Ct (Shawn Olson)

Resident is requesting flashers for the crosswalk across Blackstone Blvd where it intersects with Berg Pl and Boulder Ct. The reason I'm requesting one is because I run a private day home and every day I wait for some of the children I look after to cross the road where the bus drops them off and so many times vehicles blow past them without letting them cross the road, so I'm very concerned for their safety and I feel one of those bright flashing crosswalk signs/lights like the ones that are placed in two other spots on Blackstone Blvd would help immensely.

<u>November 14, 2024 Meeting</u>: TAC reviewed the intersection and recommended that speed awareness signs continue to be active along Blackstone Blvd with the hope that this will reduce speeding. RCMP and enforcement will monitor the area for speeding concerns and infractions concerning school buses.

Decision

TAC Recommends to Council that speed awareness signs remain active along Blackstone Blvd and RCMP and Enforcement Services monitor the area for speeding concerns and infractions concerning school buses.

Background

8. <u>Traffic Signal Request for Multiple Intersections on Hwy 39/50 Ave (Mayor Bob Young)</u>

Resident is requesting left-hand turn signals along Hwy 39/50 Ave where it intersects with Alton Dr, Grant McEwan Blvd & West Haven Blvd. I'm drawing your attention to a potentially dangerous traffic collision issue. Traffic travelling west has the benefit of left-hand turn signals at Alton Drive, Grant McEwan Blvd and West Haven Blvd. Traffic travelling east into the City does not, although the traffic lights appear to have the turn signals in place. Living in Bridgeport, I have witnessed many near accidents as east bound drivers edge to their left in these intersections, trying to turn left but having their view partially blocked by west bound vehicles waiting in line to turn left after their turn signal time has expired. I believe it is only a matter of time before a serious accident occurs. Would it be possible to provide at least a short LH turn signal for east bound vehicles at these very busy intersections. Thank you

<u>November 14, 2024 Meeting:</u> TAC reviewed the intersections and concluded that due to a recent traffic accident at the Alton Dr intersection the traffic signals are not functioning as originally programmed. The left advance signal at Grant McEwan Dr intersection will be activated at the completion of Grant McEwan Blvd construction. The intersection at West Haven Dr has the infrastructure in place to facilitate the left-hand advance signal, however the programming may need adjustments.

Decision

TAC Recommends to Council that the signal programming at the West Haven Dr and Alton Dr intersections be reviewed and adjusted as needed.

Action

Public Services to review programming and adjust signals as necessary

12. Request to Extend the Left Turn Bay for Eastbound Traffic on 50 Ave Turning Northbound onto 50 St (Blair Martin)

Blair requested that TAC consider realigning the westbound lanes along 50 Ave to accommodate extending the left turn bay for eastbound traffic on 50 Ave turning northbound onto 50 St, to alleviate traffic congestion.

<u>November 14, 2024 Meeting</u>: TAC reviewed the area and recommended that this request be brought to the Engineering department for further investigation into this possibility and the findings be brought back to next meeting.

TAC Recommends to Council that the Engineering department further investigate the possibility of realigning the lanes and the findings be brought back to the next meeting.

Engineering to discuss the possibility of realigning the lanes to alleviate traffic congestion
