REPORT TITLE: Airport Vicinity Protection Area Impacts on City of Leduc

#### REPORT SUMMARY

The Airport has distorted the configuration of the City of Leduc. The implementation of the current Airport Vicinity Protection Area creates ongoing costs for the City of Leduc. City of Leduc representatives will be speaking to these ongoing costs.

#### **BACKGROUND**

#### Origin of the EIA Tax Share Agreement

The EIA tax share agreement originated out of an 1988 annexation decision from an application in 1986 by the City of Leduc to annex a significant area in Leduc County including the Edmonton International Airport, Nisku Business Park Saunders Lake area, and lands west of the City of Leduc.

The provincial government at the time decided that instead of granting the lands to the City of Leduc, it would direct a tax sharing agreement. The fundamental rationale for the tax share agreement involved the environmental impact of the airport on the City of Leduc and the housing of workforce within the City of Leduc.

The Local Authorities Board (the annexation hearing body of the day) concluded as follows "The City, because of its location and housing of approximately 30% of the staff, and the **Airports negative environmental impact**, is in equity entitled to some proportion of the revenue." J.V.H. Milvain, Chairman. Board Order No. 18534.

The provincial government then followed up with a provincial directive for tax sharing. The provincial directive acknowledged the environmental impact of the Airport on the City of Leduc. "The Airport has unnaturally distorted the configuration of the City leading to extra municipal costs." The government of the time concluded as follows "It is clear that the impacts upon the City from Nisku, the Airport and with respect to other municipal matters identified by the Board should be resolved by tax sharing at the Airport." Order in Council 297/88.
